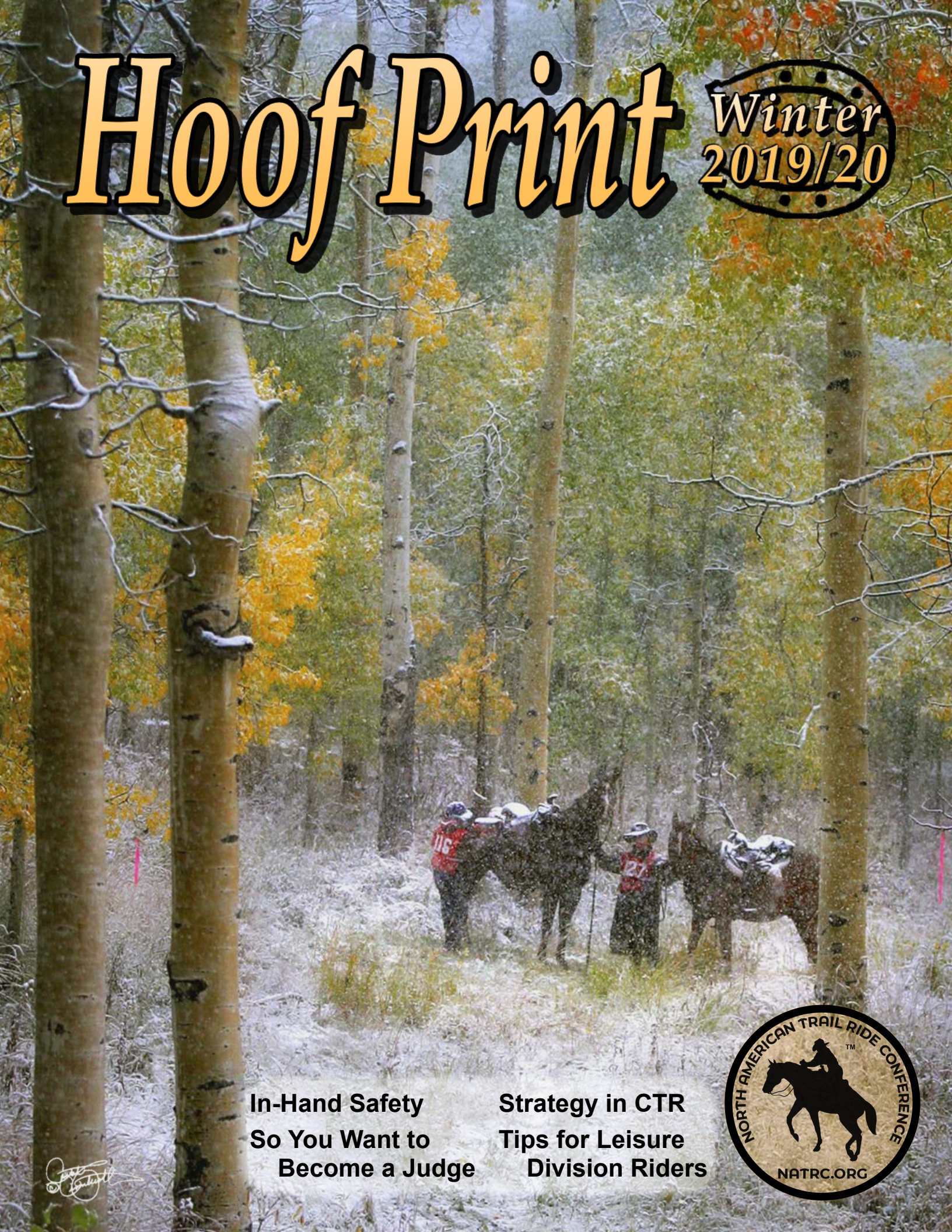

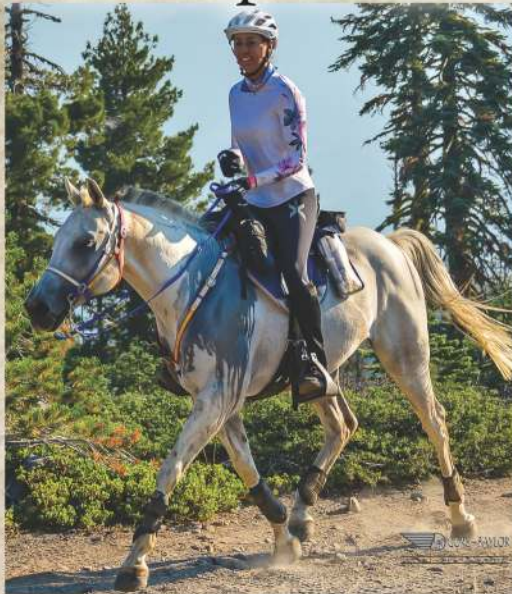

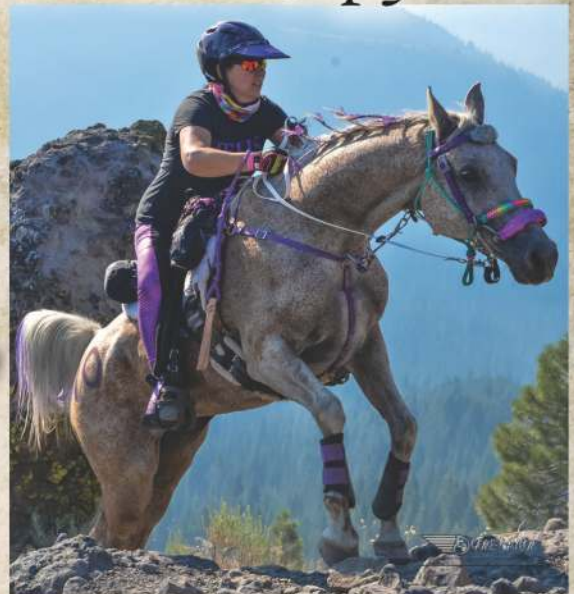

flakes and by the time we left, it was coating everything, including the riders.

From the Executive Director...

The Third Blue Loop

I've been at this sport for a very long time, since I was knee high to a grasshopper. I could be readily identified as one of the "youngest old timers" in NATRC. With these years one becomes salty with experience, savvy, skill and an outstanding ability to problem solve...right? As much as I'd like to say yes, I'm going to qualify that statement with the fact that I am human and therefore subject to moments of questionable judgement and error. Now I'm going to tell you a little story...

Not so long ago, in April of 2017, I traveled to a lovely ranch in Texas with my good friend, Helen Smith, to compete at the Tarrant Ranch ride near Bullard. It was Helen's first long trip with a horse to a competition out of region, and I was going to "show her the ropes." Our travels started off like a fairy-tale ... the Nebraska sun shining... the birds chirping... our horses loaded into the trailer like a dream.

Helen was smiling as usual and full of unbridled enthusiasm. I was on a mission, behind the wheel with our travel plans and timing all laid out into a careful itinerary. We made our overnight stop at Lake Carl Blackwell near Stillwater, Oklahoma uneventfully. We enjoyed supper and drinks at my traditional southbound Mexican restaurant, El

Vaquero, that evening after bedding down the horses in their pens, and breakfast at the Smokey Pokey the next morning before hitting the road for the remainder of our haul to Texas. What can I say? I'm a creature of habit. The waitresses know my orders by heart, and I like to share my favorites with my friends!

As we approached Canton, Texas, I felt some abnormal vibration and pulling so I slowed down as I heard the subsequent bang knowing full well what I'd find when we pulled over. *A blown trailer tire, with only 50 miles left to get to the ride site.*

The traffic on the interstate was extremely heavy, so heavy that I was afraid to access my tire changing equipment housed in the under-manger storage. Not only were my mangers on the interstate side, but my equipment was buried *somewhere* under lawn chairs, horse blankets and a set of extra stirrup fenders. I swallowed my farm girl pride and called Trailguard for roadside assistance, and they promptly responded and got us safely back on the road in about thirty minutes. **Lesson #1 – Keep all of your tire changing equipment in the rear tack area of the trailer, or at least a spot that will not require you to battle traffic while retriev-**

ing it. In addition, ensure it is not hopelessly buried.

When we arrived at the entrance to the ranch, I caught motion out of the corner of my eye through my passenger side mirror. We were at just the right angle that I could see the side of my trailer, and with a feeling of instant panic, I knew what I would find when I exited my truck. *The door to my living quarters was wide open.* This had happened once before coming back from a Kansas ride, so I knew I needed to keep the door locked at all times during travel to prevent that.

During our tire-changing stop, we had gone into the living quarters to use the restroom and get drinks while waiting, and I had failed to check if I'd locked the door before we started back down the interstate. How long it had been swinging I do not know... what I do know was that my prized Dublin Pinnacle riding boots were placed right near the door the last time I looked, and they were the only pair of riding boots I had along for the trip. In addition, my beloved heirloom steer head boot jack from my cowboy grandfather had also been by the door. Luckily, neither the boots nor the boot jack had moved from their locations just inches from the door. **Lesson #2 – Keep valuable items away from the trailer door during travel and make sure to properly latch and lock said door. In addition, have a spare pair of riding boots or shoes just in case.**

Helen and I had an absolutely fantastic camping spot with wonderful neighbors and the best spring fed water source for our horses. We enjoyed a quiet ride before check in followed by ride briefing. I paid close attention during ride briefing, took my usual notes, noted P&R info and then went about my evening caring for my horse, double checking map mileage and timing, and socializing with my NATRC family.

The next morning, Helen and I hit the trails and had a good and relatively uneventful day aside from tornado warnings and tornado activity in the area that night. We all stayed unscathed and safe in camp. On Sunday, we were riding the same trails but riding them in reverse, so I wasn't concerned about the route. One could say I was a bit complacent. Helen and I rode together again until we got separated by a lengthy judging observation that put most of us about five minutes apart. Five minutes doesn't seem like much until you realize you haven't heard or seen hide nor hair of another horse and rider for quite a while!

There was a section of our route where Open was instructed to deviate off the main trail to do three blue loops. I cruised through loops one and two with no problem and then entered the third blue loop without question. I was feeling good, my horse was feeling good, and we were on top of the world in our quiet isolation trotting through the third blue loop until we came upon a large burned out stump my horse was certain was going to

spew equine eating trolls. He set into an airs above ground spook that would give the most decorated Lipizzaner stallion a run for his money in the capriole movement as I managed to stay securely aboard.

We continued down the trail but it didn't take long before my intuition was telling me this loop was going a bit longer than it should. A while later I could sense my horse getting apprehensive again, and sure enough, we came upon the same burnt out stump from the previous impressive "goats leap" spook. At that point, I was completely confused and decided to ride ahead slowly to carefully seek the exit I had clearly missed the first time around. I double checked my map, but it wasn't aiding in my self-rescue from the third blue loop. I rode and rode and rode some more with no trail marking or clear exit presenting itself.

Once again, my horse became apprehensive and I knew what I would find. *The goat leap burnt out stump that housed the equine eating trolls, yet again.* Even my horse was looking back at me like I was nuts, and I was sure I was truly in the twilight zone of CTR, or maybe even abducted by aliens. I was a Marine for goodness sake...I had done miles of land navigation in daylight and dark in the swamps of North Carolina. How could I not extract myself from the third blue loop?

About that time, I received a phone call from Shane Murphy at the P&R kindly asking me where in the heck I was because I had been riding towards the front of the Open

pack, and now all of the Open were through the last P&R except for me. I said I had no idea where I was (possibly using more vibrant language), only that I was lost somewhere in the vortex of the third blue loop. I decided to make my way back to the entrance of the loop since I knew exactly where that was, and got back on the main trail. Sure, I came hammering into the P&R at a full hand gallop from the wrong direction but I didn't care...I found civilization and had escaped the third blue loop! **Lesson #3 – When you realize you have done a loop twice...stop, regroup, study your map and make a phone call to management (if you can) before embarking on the loop for the third time.**

Sunday after awards Helen and I said our farewells and started driving so we could make it back to Stillwater to overnight again. I normally top off my tank as close to arrival at ride camp as possible so I don't have to fuel up for a while upon departure, but due to our travel delays I wanted to get to camp and decided I had plenty given a fuel station was not terribly far from the ranch. I had a half a tank of diesel when we arrived, and under normal circumstances, it would have been more than adequate.

Ultimately however, what I would find...*it really wasn't enough this time.* Particularly when all pumps were disabled within approximately 70 miles of ride camp due significant destruction from tornadic activity to the Canton area the night before. I reached out to my dear friend, Jonni Jewell, as I knew she was traveling behind me and had extra fuel, just in case she found me roadside. With some good fortune, we managed to roll into my beloved "Buc-ee's" on fumes with 15 miles to empty reading on my gauge. It was way too close for comfort as even upbeat glass-half-full Helen was visibly apprehensive in that moment! **Lesson #4 – Always fuel up before you arrive at ride camp, no matter what, and carry extra containers of emergency fuel with you.**

Back on the road after our low fuel scare, I was relieved and eating my favorite "Buc-ee's" large polish sausage wrapped in a tortilla on a stick, warm roasted praline pecans and maybe a bag of sticky sweet Beaver Nuggets...but who's keeping track? Helen and I were tired and ready to get to Stillwater for some rest. It was 11:30 p.m., and we were 20 miles from our destination when I felt the all too familiar vibration, drag and heard the subsequent bang. I knew what I'd find...*another blown* (Continued on page 6)

trailer tire. It was late, it was dark, another busy interstate and we were tired, so I once again swallowed my farm girl pride and called good old Trailguard. Despite the late hour and the desolate rural area of Oklahoma we were in, we had assistance and were back on the road in under 40 minutes. **Lesson #5 – Have a reliable roadside service agency that kindly provides ready, rapid and thorough service even if it's the second service call in one weekend.**

In case you are wondering, yes, my mishaps and twilight zone ride are the butt of

a few jokes amongst Helen, myself and our Region 4 family, but it's all in good fun and memories. We live, learn, grow and maybe rearrange a few things in our trailers and safety plans as a result.

I definitely showed Helen the ropes...of what not to do when traveling long distances with your horse and navigating trails. Helen was a trooper and was always positive as we rolled with the punches through our wild weekend. **Lesson #6 – The final lesson of this story...we will all be humbled at some point in this sport and can find ourselves**

stuck in the third blue loop regardless of our experience and perceived level of preparation. Be able to laugh at yourself, learn from your mistakes, and most importantly, travel in the good company of positive and flexible friends to share the adventure with when you can!

4-H Junior Rider Year End High Point Award

Put your valuable 4-H skills to use outside of the arena and compete for this special award. Trail riding is a great way to cross train your horse for shows, safely practice your equitation and communication in a more scenic setting, and even put those showmanship skills to use during the in-hand vet checks! Encourage your fellow 4-H friends to join you in competitive trail rides and compete for NATRC's 4-H Year-End High Point Team Award. Contact us if you would like a presentation to your club to introduce the sport and answer questions.

To be eligible is simple. Just compete in any division, nominate yourself, and prove that you are a 4-H member! Here are the specifics:

- 1) The award goes to the high point horse and rider team **regardless** of the division.
- 2) Your self-nomination must occur before the end of the ride year which is the second Sunday in November. (For 2020, that will be November 15th).
- 3) You must: (a) be an NATRC competing member, (b) contact Sarah Rinne at natrc@natrc.org to nominate yourself, and (c) have your 4-H leader contact Sarah to verify that you are a 4-H member.

NATRC Student Loan & Scholarship Program

Student loans and scholarships are available according to the budgeted amount, at the discretion of the National Board of Directors. Preference will be given to a full-time student who has been a member of NATRC or whose family has been an active member for at least 3 years. Consideration will also be given to a student or a student's family who has been an active member for less than 3 years but more than 6 months.

In-hand Safety

“Why should we always turn the horse away from us when making a 180 degree turn in hand?”

First, a little history. Back in the 1980s, when I first got my judges card, lunging of horses for the circles at check-in was brand new. Prior to then, everybody trotted the circles in-hand with his or her horse, so everybody made a 180 degree turn at some point. It was common for judges to teach you (via point deductions) to turn your horse away from yourself when changing directions.

Fast forward to today! Most everyone lunges the circles. Riders work on lunging nice, smooth circles and rarely have to do a full 180-degree turn. Judges often do not get an opportunity to see a full turn, plus we try to “judge the results,” so we haven’t been “teaching you” to turn the horse away from you with our point deductions. Consequently, a lot of very experienced riders turn their horse into

themselves instead of away when they finish the circles and turn to trot back.

The question comes up from time to time. Those that had been in 4 H or Pony Club, or had ever shown in halter or showmanship know the “correct” answer: “It makes it harder for the horse to step on you, and it doesn’t block the judges view.” The more interesting responses come from people who had good control of their horses but had never been taught “showmanship.” They think that it is awkward and not as safe as turning the horse around you. These are reasonable responses that make good sense to those who have control of their horses. If you truly have control and are attentive to your horse, then you can handle either situation.

My response is as follows: *“First, we are assuming that your horse will be handled and lead broke by the time you bring him/her to a CTR. So, the scenario of a goofy horse dancing around you is not what we are talking about. In the process of TRAINING your horse to turn away from you, you are forcing him to RESPECT YOUR SPACE, and you are forcing yourself to THINK about where your horse is. It is true that an unsafe horse is equally unsafe whichever way you turn him, but a well-trained horse will be much safer if you turn him away from you. Why? Well, because you HAVE TO PAY ATTENTION, and will not inad-*

vertently lead him toward you with your back to him (because he is calm and you are relaxed) and cause him to step on your heels as he reaches into the turn.

As someone has pointed out, the most important aspect of lead training a horse is teaching him to move away from you and respect your space. Just coming forward because you pull on the rope without the respect will get you trampled. A horse that runs past you, drags you, or shoulders into you is unsafe. Making a circle around you actually encourages the horse to run past you. It IS easier to let the horse go around you (unless of course, he goes around you and runs past you or over you). It takes more discipline and control to make the horse slow or stop and make a turn away from you.

MORE DISCIPLINE AND CONTROL is ALWAYS safer than less. *Once your horse is habituated to respecting your space, he is unlikely to run over you even if he shies at something on the other side. He needs to think that you are more important than the biggest booger out there. Teaching him to always move away from your space will help impart that idea.”*

Another important point about presentation is that your horse should have freedom to move his head so that the veterinary judge can evaluate soundness. If you teach your horse to respect your space and stay with you, then you can allow a longer length of lead between your hand and the halter. Most horsemanship judges are looking for good control and a smooth presentation. When your horse learns to respect you, it all comes together.

In conclusion, stopping and turning your horse away is the surest way to demonstrate good control. This is not just an NATRC thing. All 4-H, CHA, and NARHA students and instructors are trained to do it this way. It’s not just a “showmanship” thing. It’s a safety thing. Think of it as an in-hand obstacle. Doing it this way assures that you and your horse are thinking about each other and working as partners. Any turn that involves turning your back to your horse, even momentarily, is not a safe turn. So go out there and practice, just in case you are asked to do a trot out and back.

So You Want to Become a Judge...

The details for becoming an approved NATRC judge are in the Judges Manuals. Here is a quick summary.

Veterinary

To become a veterinary judge, a person must have a degree in veterinary medicine, file an application, and complete a test on basic NATRC rules and procedures. On satisfactory completion of the test, the Judges Committee approves the applicant as an apprentice judge.

The apprentice judge typically works at least two rides with an approved veterinary judge. The nature of the apprentice judging varies with the supervising judge and the appli-

cant's background and experience. Following the rides, other ride judges and the ride chair or rules interpreter submit progress reports to the Judges Committee. After reviewing the reports, the Judges Committee, if satisfied, advances the applicant to provisional status. A provisional judge may judge independently and receive a fee. Ride officials again submit progress reports to the Judges Committee.

Upon satisfactory completion of the apprenticeship, the Judges Committee presents its recommendation to the national board, who votes on the issuance of an Approved Judge's Card.

Horsemanship

To become a horsemanship judge, the applicant should be an accomplished equestrian with knowledge of horses, their care, and horsemanship as related to our sport and meet the following requirements:

- complete at least ten NATRC Open Division rides

- acquire a minimum of 100 horsemanship points in the Open Division
- serve as a judge's secretary
- assist management in planning, measuring, marking and timing of trails
- serve as a P&R team member on the trail throughout an NATRC ride
- place 4th or higher in year-end placings for Open Division horse or horsemanship
- file an application with the NATRC office
- complete a test on basic NATRC rules and procedures scoring 90% minimum

The Judges Committee and the NBOD may accept equivalent experience and qualifications.

After the Judges Committee approves the applicant as an apprentice judge, the applicant judges at least four rides as an apprentice under a supervising judge and three rides as a provisional judge. After each ride, other ride judges and the ride chair or the rules interpreter submit progress reports to the Judges Committee. If the Judges Committee is satisfied with the evaluations, the committee advances the applicant to provisional status. Provisional horsemanship judges may judge independently and receive a fee. Again, ride officials submit progress reports to the Judges Committee. The committee reviews the scorecards from the provisional rides for consistency and accuracy. In addition, the apprentice/provisional judge submits reflections on each ride to the horsemanship co-chair and to the education committee chair for review and feedback.

Upon satisfactory completion of the apprenticeship, the Judges Committee presents its recommendation to the national board, who votes on the issuance of an Approved Judge's Card.

judge are in the Leisure Division Judges Manual.

An applicant must possess an interest in competitive trail riding, have a thorough understanding of the purpose of NATRC, be a member in good standing and meet the following requirements:

- be at least 21 years old
- complete a minimum of 750 miles in any division
- be a secretary for a horsemanship

- judge
- know and understand NATRC rules
- know and understand the Leisure Division Judge's and Management Manuals
- pass a written exam, and upon completion, participate in a Leisure Division Judges training seminar

Further Information

All judges must annually renew their approved judge status. Veterinary


judges must do at least one of the following, and horsemanship and LeD judges must do at least two.

- judge
- attend a national or regional judge's seminar
- conduct or assist with a clinic
- compete in a ride
- serve as ride chair, rules interpreter, P&R chair, judge's secretary or trailmaster

The Judges Committee typically consists of veterinary judges, horsemanship judges, and rider representatives. The president appoints them and the NBOD approves them. Our executive director, president and education chair are non-voting members of the committee.

In addition to approving and supervising the apprentice/provisional process, the Judges Committee investigates concerns, complaints or protests regarding a judge who may have failed to judge according to the rules, guidelines or philosophies of NATRC. The board makes the final decision on any recommended action.

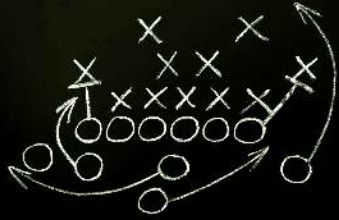

Strategy in CTR.



Really? - Part 2

You bet! Once you arrive at ride camp, there are decisions to make to support a strategy of comfort and low stress during your down time during the long weekend.

Locating and orienting the rig is especially important for the horse when tied to the trailer. Should exposure to morning sun or afternoon sun be the choices, choose shade for the afternoon. After hours on the trail in heat and humidity, the cooler shade will help your horse recover faster, just like you. Those riders who have living quarters trailers with air conditioning can hardly wait to chill out! In the morning, more than likely you will be timing out a little after dawn. No need for shade then.

If camping is primitive (no electricity), campers, without generators to run their air-conditioning or with no A/C at all, often park so the prevailing breeze blows across their sleeping areas.

If using high ties or supplied pens, always seek a campsite where the horse gets first dibs on the shade!

Because most rides are in warm weather, it goes without saying (but, hey, here it is anyway) that the opposite shade strategy is the ticket when attending a cold weather ride.

Standing in the sun after a day on the trail will help keep your horse's muscles warm and reduce potential stiffness and soreness.

There is strategy in selecting a neighbor when camping in close quarters and with horses tied to their trailers. Be it a friend or a stranger (who most likely will

become a new friend), consider which side of the trailer to which s/he ties her/his horse. To avoid a potential kicking bout, horses bud-dying up, or riders disturbing each other's horses, savvy riders orient their trailers so that the trailers are between their horses. If a trailer cannot be a barrier, stagger the trailers to leave plenty of clearance for the horses who share the open space between two trailers.

Riding a stallion? Consider camping with geldings as neighbors. No need to lose sleep because of snorting, whinnying, and trailer jiggling as Romeo tries to entice the nearest Juliet who is in heat.

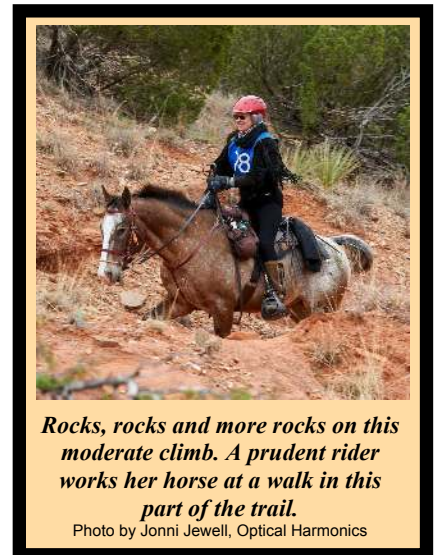
Ride briefing is where riders receive a map for the next day's trails. The trail master discusses pertinent landmarks, terrain variations, water

locations, pulse and respiration (P&R) locations, trail length, trail

condition, average pace, completion-time window, checkpoints, signage, and more. The strategy here is to pay attention, make notes and ask questions on anything not understood. The more riders know about the trail, the better they are able to pace themselves. Here is an example:

The point-to-point times on the map are usually mathematical averages based on the overall average pace for the entire day's ride. A 25-mile ride done in 5 hours has an average pace of 5 mph. It is simply the distance in miles divided by the average pace.

Say the distance from Point B to the first P&R is 5 miles and the average pace is 5 miles per hour, then it will take 1 hour to get to the P&R. If the trail for that segment is mostly a flat dirt trail, making that time is a piece of cake. If the trail is up a steep rock strewn hill on a twisty trail with few clear level places to make time and down the other side in the same kind of conditions, then the best time one can

make is likely around 4 mph – a far cry from 5 mph. It will take 15 minutes longer to cover that rough trail than it will an easy one (5 miles / 4 mph = 1.25 or 1:15 (.25 x 60 = 15 minutes).

By understanding the terrain from the trail master's discussion, after briefing, you can go back to your trailer and plan your ride based on where you can (Continued on page 15)

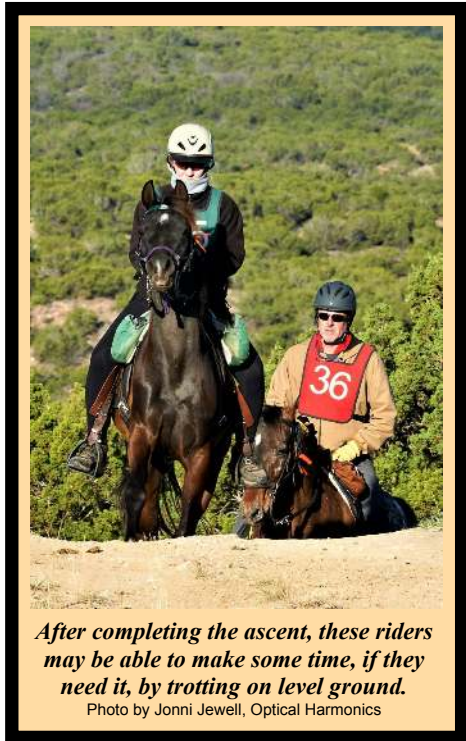


The trail master has chosen a topo map to show the trails. From this, riders can see where they will have to go slow and where they can make time. Pay attention. There is good information for your strategy.

make time and where you cannot. By planning to ride faster in the first two segments – camp to A and then A to B – you can plan on being 15 minutes early to B. You can then plan to slow down for the rough



stuff, and still be on schedule at the P&R without risking injuring or overly stressing your horse by trotting through the nasty stuff from B to the P&R.

Remember ... strategy is the art of devising a means to an end with a favorable outcome. Less stress, more enjoyment.



Core Muscles

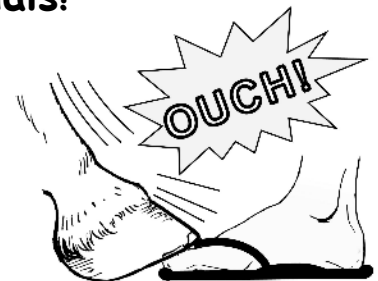
Did you know that strong core muscles are one of the secrets of the strength of the Navy Seals? Strong core muscles (back, side, pelvic and buttock muscles) help stabilize the spine and help create a strong base of support for nearly all movement. Flat abs and tighter tummies don't happen in a few days. They must be part of a regular program. Strong core muscles will help your general posture, healthy appearance, and riding equitation. The American Council on Exercise, www.acefitness.org, has some great animated exercises to do to help get you started.



Safety First!

No Sandals!

Sturdy boots and shoes protect your feet and Achilles tendons when you're working around horses. No flip-flops or sandals at the in-hand presentation, please. Safety first!

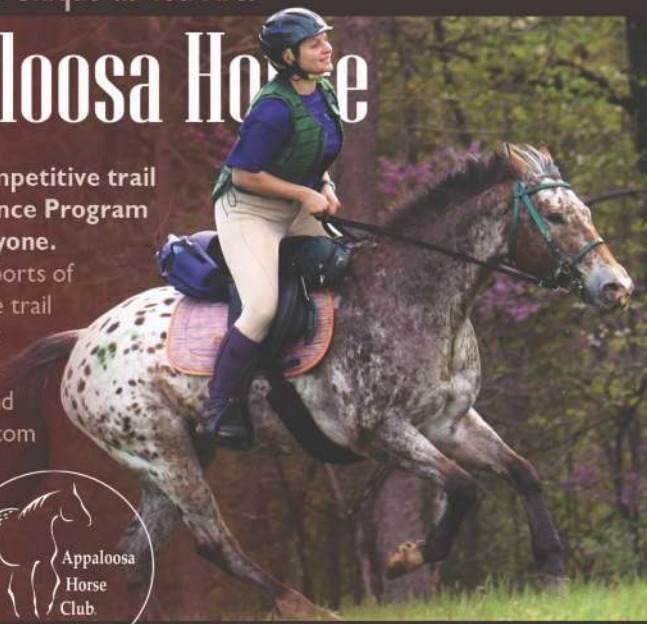

Tips for

Leisure Division Riders

(and Novice, CP, and Open Riders)

Check in:

- ◇ Stand on the same side of your horse as the judge for safety (yours and the judge's)
- ◇ Fold, don't loop or coil excess lead to prevent injury. Avoid excessively long leads
- ◇ Keep two hands on the lead for better control

In hand trot:

- ◇ Stay at horse's shoulder to give him more confidence
- ◇ Allow about 12 to 18 inches between halter and your hand on the lead to give the horse's head room to move
- ◇ Turn horse away from you (to the right if on the near side) for safety

Mount:

- ◇ Maintain rein contact and control
- ◇ Use natural terrain or mounting block to keep you from pulling on the horse's spine
- ◇ For safety, do not dwell in stirrup or drag leg over rump
- ◇ Settle lightly in saddle
- ◇ Keep the horse steady and still before you move off

Uphill:

- ◇ Bring torso slightly forward by bending at hip joint; keep hips balanced over legs
- ◇ Be light in saddle rather than out of saddle
- ◇ Shift weight through thighs to stirrups, but don't stand up
- ◇ Maintain soft rein contact and allow horse to use head for balance

- ◇ Hang onto mane above rein hand for better balance if necessary

Downhill:

- ◇ Sit centered in saddle and avoid leaning back or too far forward
- ◇ Avoid swaying side-to-side; put pressure into your stirrup with each stride
- ◇ Maintain soft rein contact

Backup:

- ◇ Settle horse; look behind you
- ◇ Give and take with reins, one step at a time
- ◇ Use leg aids for directional control

P&R:

- ◇ Dismount, take reins over the head or connect to the halter
- ◇ Line up parallel to the other horses; maintain control
- ◇ Stay quiet, don't make quick gestures; use a quiet calm voice
- ◇ Use a fan or water & sponge to cool the horse
- ◇ Unsaddle if necessary
- ◇ Check to see if it's OK with the rider after you before leaving

Trail Safety & Courtesy:

- ◇ Make sure your rider number is visible
- ◇ Keep at least one horse length between horses (don't crowd)
- ◇ Approach other riders from behind slowly and ask permission before passing at a walk
- ◇ After passing, move on to create a quiet pocket
- ◇ Wait for next horse at obstacle/ gate/ etc.

Reminder About Year-End Awards and Breed Awards

1. To be eligible for year-end awards, NATRC competing membership dues must be paid by the second Sunday in November, the end of the Ride Year.
2. Many breed organizations sponsor year-end high point breed awards. Memberships in NATRC and the breed association are required, so be sure to keep your breed association membership current.
3. It is the responsibility of the owner of the horse to accurately report/verify the horse's breed to NATRC.
4. Questions about the horse and/or rider records should be directed to NATRC, natrc@natrc.org.

PROPOSED BYLAWS CHANGES 2019 - APPROVED

Thank you for voting. The National Board of Directors approved the proposed changes based on the results of your ballots.

Changes below are **BOLD**. Explanations for each change are in all capital letters.

ARTICLE IV. BOARD OF DIRECTORS

Section 1. The board of directors shall consist of two members from each of the six regions, a total of 12. The term of each member shall be for a period of three (3) years. The term of office for directors shall begin on January 1 following their election **and end on December 31 of the final year of their term.** The terms shall be staggered so that four regions elect one member **at the fall meeting of the board of directors** in years when a term expires ~~at the fall meeting of the board of directors.~~

Section 2. Each region shall elect an alternate director. This election shall be held concurrent with the normal election of directors and shall be for a term of three (3) years. The terms shall be staggered so that two regions elect one member **at the fall meeting of the board of directors each in years** when a term expires ~~at the fall meeting of the board of directors.~~ This alternate director will automatically be seated whenever a sitting director is unable to attend a meeting.

NO CHANGE IN PROCEDURES; CLARIFIES THE TIME FRAME FOR TERM OF OFFICE AND ELECTION OF NATIONAL BOARD.

ARTICLE VI. PRESIDENT

~~Section 4. The president shall appoint a point secretary, not necessarily a board member, who shall receive the score cards for each ride and shall keep an account for the high score awards and shall regularly publish the standings during the corporation's competition season.~~

SCORECARDS ARE NOW RECEIVED AND POINTS RECORDED BY THE NATIONAL OFFICE; POINT SECRETARY OBSOLETE.

ARTICLE X. MEMBERSHIP

Section 1. Any person interested in the purposes and objectives of this organization may be eligible for membership, and upon proper application and payment of ~~the any~~ required dues, may be accepted in membership.

Section 2. ~~There shall be Junior Members, Adult Members, Family Members, Adult Lifetime Members, Family Lifetime Members and Associate Members. The board will determine the dues, classifications and privileges of these members and cause the rule book to so state.~~ There shall be Junior, Adult, and Family competing memberships, Adult and Family Lifetime memberships, and Supporting memberships. The board may add non-voting memberships. The board will determine the specific classifications and privileges of each and cause the rule book to so state. The board will also determine the dues for each classification.

Section 3. Lifetime Members will be either paid or honorary. Regardless of the type of lifetime membership, in years the corporation is profitable, a portion of this membership fee will be deposited into the NATRC Foundation funds.

Section 4. **Each Adult competing, Adult Lifetime, and Supporting membership is entitled to one vote. Each Family competing and Family Lifetime membership is entitled to two votes.** No member shall be entitled to vote unless he/she is **a paid-up member current on all dues and** in good standing at the time when such voting takes place.

REDEFINES THE MEMBERSHIP STRUCTURE AND VOTING PRIVILEGES. ACCOUNTS FOR FREE AS WELL AS PAID MEMBERSHIPS.

ARTICLE XIII. COMMITTEES

Section 4. Nominating Committee:

- (a) Each region shall appoint a nominating chair and, if deemed advisable, a nominating committee. This chair shall nominate annually, sufficient individuals to fill the positions of national board members/alternates whose terms expire at the end of the year.
- (b) Nominees must be and have been voting members for at least two (2) full fiscal years previous to the year of nomination. Nominees must, in the opinion of this chair, be active as a competitor, or as a judge, in ride management or NATRC management.
- (c) The chair shall give due consideration to geographical areas and states, and to different categories of occupation, so that the board of directors is widely representative of NATRC and is a true composite of the leadership thereof.
- (d) At least thirty (30) days before the fall meeting of national board of directors, the regions shall submit to the voting members of their region a slate of nominees for the vacancies to occur on the national board of directors. Such ballots shall also provide space for nominees to be written in by the members. **The tabulation from each region shall be submitted at the fall meeting of the national board of directors.**
- (e) Each region's nominating chair shall report the results to the president of NATRC who shall cause an announcement of the election to be made **thereafter at the fall meeting of the national board of directors.**

Trailer Insulation

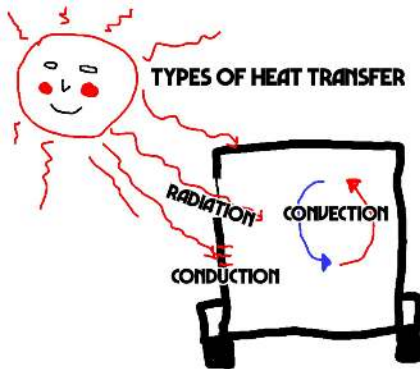

Insulation is one of the first steps in any DIY build, and it's also one of the most misunderstood. There's a lot of misconceptions about trailer insulation, and people end up wasting money and time on unnecessary steps and products.

When we were building our trailer we had all kinds of questions about insulation: What's the best material to use? How do we install it? Do I need a vapor barrier? What questions do I not know enough to ask?

So what is the best way to insulate a DIY horse trailer? Below, we'll go over how heat is transferred and how to stop it; discuss everything you need to know about insulation, the different products out there, and how best to use them.

There are three types of heat transfer: radiation, conduction, and convection.



Radiation is heat that can be transferred through the air or a vacuum - think of the warm sunlight that comes through your windows on a sunny day. It's very nice in winter but miserable in the summer. In a trailer, radiation occurs mostly through the windows. If you park your trailer with large windows in direct sunlight, the inside will heat up quickly. This is because radiant heat transfers easily through glass. Combat radiation heat by parking in the shade or extending your awning.

Convection is heat transferred through the natural movement of liq-

uids and gasses. This is due to liquids and gasses being different densities and temperatures. In a nutshell, hot air is less dense than cold air so it rises, which is why the nose of gooseneck trailer gets so hot in the afternoon. Combat convection by adding a ventilation fan to suck out the warm air near the ceiling while pulling in cooler air from a cracked window.

Conduction is heat transferred through a solid material. The metal skin and framing of your trailer walls are excellent conductors of heat. Without any insulation, a trailer sitting directly in the sun heats up fast. The inside metal can be too hot to touch because the heat is transferred very efficiently through the outside walls. Combat conduction by insulating the inside of your trailer to stop your trailer from conducting the sun's heat inside during the summer and help prevent heat loss through conduction during the winter.

Insulation slows the rate of heat transfer into and out of your trailer, which makes it easier to maintain the temperature you want. A properly insulated trailer is easier to heat and cool. It won't heat up as quickly in the summer, and stays warmer in cool weather.

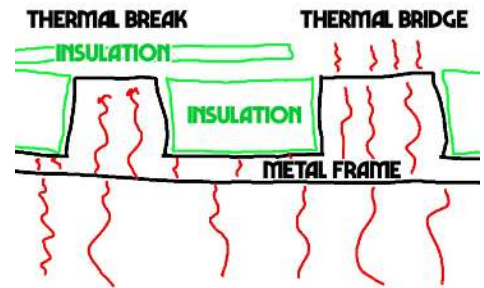
Every insulation material has an R-value, which is a measure of the material's *Resistance* to heat transfer. The higher the R-value, the better the ability to resist heat transfer via conduction.

Different materials have different levels of conduction. In general, the more porous a material is, the less it conducts heat because air is a poor conductor. Example: If you hold a metal bucket full of ice, it will quickly draw the heat out of your hands. If you hold a foam bucket full of ice, the heat will stay in your hands.

Nothing resists conduction better than a vacuum; this is why vacuum insulated mugs work so well.

A **thermal bridge** is an area that has greater thermal conductivity than the materials around it, providing an opportunity for heat to pass through.

When you place insulation between your trailer's frame ribs but don't do anything to the ribs them-



selves, the frame then becomes a thermal bridge. Heat can conduct inside the trailer through the exposed frame much more easily than it can through the insulated areas. This thermal bridge reduces the overall effectiveness of your insulation, since heat and cold can easily go around it.

Insulating on the top of your trailer's hollow frame ribs can reduce the effect of thermal bridging. These thermal breaks, are basically non-conductive materials (i.e. insulation) placed in the pathway of a thermal bridge to block the flow of heat.

NOTE: HVAC tape is not insulation.



While an insulated trailer with some thermal bridging is more resistant to heat transfer than a trailer with no insulation at all, we're embarking on this project to do as good a job as we can.

Now that we understand how basic heat transfer works, let's take a look at the insulation materials we can use to slow it down.

While there are a lot of options out there, not all of them are good choices for insulating your trailer. Good trailer insulation needs to have the following:

- **High R-value** per inch. Space is at a premium inside a trailer, and you want to insulate with materials that will do the most in the least amount of space.
- **Bang for your buck.** There's no need to spend hundreds of dollars insulating your trailer. Some materials may work well, but cost more than your trailer did. The best insulation materials do their job effectively and are friendly to your wallet.
- **Able to withstand vibration.** Unless you've got your trailer up on blocks, you're probably hauling it all over the place. Traveling causes lots of vibrations inside your trailer, and your insulation needs to be able to take it without falling apart.
- **Resistance to moisture, mold, and mildew.** Either the material is impervious to moisture (like rigid foam board or spray foam) or has moisture control properties and natural mold resistance (like Thinsulate or sheep's wool).
- **Non-toxic.** You don't want harmful gases or microscopic particles from your insulation filling your living space. Bonus points if the insulation is produced in an environmentally friendly way.

What we used in our trailer:

Extruded polystyrene (XPS) is a type of rigid foam board insulation that's widely available. You'll recognize it as the big pink or blue foam sheets at the hardware store. XPS

has a very good R-value per inch at R-5, and is impermeable to moisture. Another benefit is its high compressive strength, making it perfect for floor insulation.

What we SHOULD have used:

Polyisocyanurate is another rigid foam board insulation. It typically comes foil-faced on one side, which both acts as an effective vapor barrier and provides a radiant heat barrier if you install it with an air gap. Polyiso is completely non-toxic and doesn't off-gas anything harmful. It's also much more environmentally friendly and has a slightly better R-value per inch than XPS foam board. It is a little more expensive, and my local hardware store didn't carry it.

What you never want to use:

Expanded polystyrene (EPS) is another type of foam board insulation. It's basically the same as the stuff in your Styrofoam cooler. EPS is super cheap and is a good insulator. But it contains a lot of air gaps that allow moisture to penetrate, which degrade the material over time. It also won't stand up to vibration as well as polyiso or XPS, and isn't nearly as durable.

Insulation Steps by the Numbers:

- 1) Insulate walls, ceiling, and floor with foam board.
- 2) Fill gaps with spray foam.
- 3) Cover all exposed ribs with thermal break. We used ¼ inch fan-fold sheathing insulation
- 4) Seal seams with HVAC tape to create moisture barrier
- 5) Attach 1x3 wooden furring strips to ribs to create a solid base for the ¼" plywood sheet walls and channels for electrical wiring

And there you have it! A fully-insulated trailer!



Now you're ready to head up to Alaska in December, or haul down to Arizona in August. Well, maybe not. No matter how well-insulated your trailer is, it's still a good idea to follow the weather you want. While insulation does make the inside of your trailer more comfortable, horse camping isn't about staying in your trailer - it's about getting out there and enjoying the world on your horse!

Layers

In order to help your horse on a really cold, wet and windy ride, you need to keep warm, too. Dress in layers – one of them being a windbreaker. Likewise, for your steed, affix a rolled up rump rug to the back of your saddle and unroll it to keep your horse's muscles warm while standing at a P&R.



2021 RULE CHANGE PROPOSALS - November 9, 2019

CHANGE LIMITS FROM PLACINGS TO POINTS FOR COMPETING IN NOVICE

SECTION 4 – DIVISIONS, CLASSES AND ELIGIBILITY

A. Divisions

2. Novice

e. Limitations

- (1) Any horse and adult rider ~~combination pair~~ having ~~won five firsts earned 250 points, lifetime accumulation~~, in horse (regardless of ~~division or class in Open, Competitive Pleasure, and Novice~~) shall not compete for awards in Novice Horse Division. Four-year-old horses are exempt from this rule. A horse and rider ~~combination pair~~ that attains ~~five firsts 250 points~~ in horse during a ride year, and competes in a novice ride in that year while still eligible for novice horse awards, may continue to compete in Novice Horse Division for the remainder of that ride year.
- (2) Any horse and junior rider ~~combination pair~~ having ~~won five firsts and 225 points earned 250 points~~, lifetime accumulation, in horse (regardless of ~~division or class in Open, Competitive Pleasure, and Novice~~) and rider having reached age of 14 shall not compete for awards in Novice Horse Division. Four-year-old horses are exempt from this rule. An age eligible horse and rider combination that attains ~~five firsts and 225 250 points~~ in horse during a ride year, and competes in a novice ride in that year while still eligible for novice horse awards, may continue to compete in Novice Horse Division for the remainder of that ride year.
- (3) Any adult rider having ~~won five firsts earned 250 points, lifetime accumulation~~, in horsemanship (regardless of horse, ~~division~~, or class in **Open, Competitive Pleasure, and Novice**) shall not compete for awards in Novice Horsemanship Division. A rider that attains ~~five firsts 250 points~~ in horsemanship during a ride year, and competes in a novice ride in that year while still eligible for novice horsemanship awards, may continue to compete in Novice Horsemanship Division for the remainder of that ride year.
- (4) Any junior rider having ~~won five firsts and 225 points earned 250 points~~, lifetime accumulation, in horsemanship (regardless of horse, ~~division~~, or class in **Open, Competitive Pleasure, and Novice**) and having reached the age of 14 shall not compete for awards in Novice Horsemanship Division. A rider that reaches age 14, attains ~~five firsts and 225 250 points~~ in horsemanship during a ride year, and competes in a novice ride in that year while still eligible for novice horsemanship awards, may continue to compete in Novice Horsemanship Division for the remainder of that ride year.
- ~~(5) A rider or horse and rider combination may compete for awards in the Competitive Pleasure Division.~~

Rationale:

With low ridership, it's possible for first-time competitors to place 1st in horsemanship when they are the only competitor in their class. Thus riders are ribboning out of Novice too soon. Limitations based on point accumulation would be a better solution.

ADD EXPERIENCED CLASS TO LEISURE DIVISION

SECTION 4 – DIVISIONS, CLASSES AND ELIGIBILITY

A. Divisions

4. Leisure

e. Classes

- (1) This division will offer **Experienced**, Adult and Junior Classes as defined in Section 4 B, **with the exception that Experienced teams are defined as:**
 - (a) Any NATRC judge (Veterinary, Horsemanship, Leisure).
 - (b) Any NATRC rider with more than 250 points of any combination of Leisure Division Team and Open, Competitive Pleasure, Novice Horsemanship at the beginning of the ride year.
 - (c) Any NATRC rider who has won a National Award in a Competitive Pleasure or Open Division.
- (2) Horse and rider will compete as a team, with their combined scores used to determine placing recognition.
- (3) **A Junior may compete in the Adult or Experienced Class.**
- (4) **Any adult may compete in the Experienced Class.**

Rationale:

Leisure is meant to be a home for riders new to NATRC and experienced NATRC riders who for whatever reason do not want to compete in a Novice, CP, or Open Division ride. The skill levels here are generally very different. We want to welcome both groups, but they shouldn't necessarily be competing against each other.

CHANGE TWO MILE POINT TO FORWARD MOTION POINT

SECTION 5 – THE RIDE

I. Trail Conduct

5. ~~Two Mile Forward Motion Point~~

- a. From a properly identified **forward motion point** (posted sign) ~~approximately 2 miles from the finish each day~~, riders must maintain forward motion and not stop or dismount from this point to the finish line except in extenuating circumstances dictated by good horsemanship and/or sportsmanship. Forward motion must be via the most direct route, without stopping, following the marked trail. Any deviation may result in penalty assessment or disqualification unless dictated by good horsemanship and/or sportsmanship.
- b. No one shall interfere with the rider's forward progress and/or pacing except when necessary for the safety of the horse/rider.
- c. **For Novice, Competitive Pleasure, and Open Divisions, the forward motion point should be approximately two (2) miles from the finish each day.**
- d. **For the Leisure Division, the forward motion point should be approximately one (1) mile from the finish.**

Rationale:

Because the Leisure Division can be as short as 8 miles, requiring that one quarter of the ride be forward motion does not seem reasonable. This limits judging opportunities, trail access, and P&R location to a very limited portion of the trail. Shortening the Leisure Division point of forward motion keeps the ratio to total ride distance similar to other divisions.

ALLOW LENIENCE IN LEISURE DIVISION TIME PENALTIES AT COMPLETION OF RIDE

SECTION 5 – THE RIDE

J. Timing and Time Penalty Points

3. Early Arrivals

a. A horse completing the day's ride in less than the minimum time and within 30 minutes prior to the minimum time shall be penalized one point per minute for each minute before the minimum time. Rider will also be faulted. **The number of penalty points for rider and Leisure Division team will be at the judge's discretion.**

b. A horse arriving more than 30 minutes early shall be disqualified.

4. Late Arrivals

a. A horse completing the day's ride exceeding the maximum time and within 30 minutes subsequent to the maximum time shall be penalized one point per minute for each minute exceeding the maximum time. Rider will also be faulted. **The number of penalty points for rider and Leisure Division team will be at the judge's discretion.**

Rationale:

To allow some judgement is assigning time penalties to the Leisure Division.

ALLOW EVALUATION OF OVERNIGHT LEISURE DIVISION STABLING

SECTION 6 – JUDGING

D. Leisure Division. Horses will be evaluated on trail ability and manners. Riders will be evaluated on equitation and partnership with the horse. Safety may be scored.

1. A veterinary judge is not required.

2. There will be a minimum of one P&R recovery reading taken during the day's ride.

3. Judges may be sourced from the approved Leisure Division Judges List or the standard list. An NATRC-approved veterinary judge may serve as the full judge for this division.

4. ~~This division is exempt from stabling evaluation.~~ **Overnight stabling will be evaluated for safety and must comply with NATRC stabling rules. This will not be scored.**

5. Horses in the Leisure Division may compete with or without boots (e.g. splint boots, bell boots) and/or the use of any temporary types of hoof or leg protection.

6. There will be a maximum of five observations per ride.

Rationale:

Equisure requires overnight stabling evaluation.

CLARIFY EXPECTATIONS OF LEISURE DIVISION PLACINGS VERSUS RIDE ANNOUNCEMENTS

SECTION 9 – AWARDS

A. Ride Awards

3. Horse and horsemanship scores for Leisure Division will be added together to determine placing teams for **Experienced**, Adult and Junior Classes. First through tenth place teams in ~~both all classes will be recognized~~ **must be calculated for awarding of points. First through sixth place awards must be presented publicly at the immediate conclusion of the ride.**

Rationale:

Announcing six placings at awards is consistent with the other divisions. Some feel it is demeaning to not make the top ten, so it is easier to only announce the top six and not draw attention to those placing well below.

ADD OUT-OF-REGION QUALIFICATION TO PRESIDENT'S CUP CRITERIA

SECTION 9 - AWARDS

B. Annual Awards

2. National Awards

a. PRESIDENT'S CUP (National Sweepstakes Champion): This award will be presented annually to the overall high point horse in the Open Division.

(1) Only the first 16 rides officially started will count. Type AA ride counts as 1½ rides; Type A ride counts as 1 ride; Type B ride counts as ½ ride. The horse and rider team shall be considered officially started when timed out on the first day of the ride.

(2) The horse must be officially started in at least ~~four one rides of any ride type made up of any combination of~~ **out-of-region and or three out-of-state rides of any ride type.**

(3) A rider must be a current NATRC competing member prior to the start of a ride for the ride to be credited.

(4) In the event of a tie in points at the end of the year, the winner shall be the horse which has won first place on the most number of rides. If the tie persists then the most number of seconds will be used. Each placing shall then be used in turn until the tie is broken.

Rationale:

The President's Cup is truly a national award. It should be expected that the winner competes against horses other than those in its own region to win this prestigious award.

- s. **HIGH POINT NOVICE TEAM:** This award is presented to the Novice Division horse and rider combination having the highest number of total points for horse and horsemanship. Only the first 12 rides officially started will count. Type A ride counts as 1 ride; Type B ride counts as ½ ride. The horse and rider team shall be considered officially started when timed out on the first day of the ride.

Age of Horses

- (1) Horses competing for High Point Novice Team award must be at least 60 months of age.

- (a) Registered horses are considered 60 months of age as of actual foaling date on the registration papers.
- (b) Unregistered horses are considered to be of eligible age if they have a “full mouth” (all permanent incisors having erupted and in wear) as determined by the veterinary judge.

Rationale:

We want to encourage Novice Division riders. We want Novice Division riders to attend the national conventions. Particularly on this last point, we need to give them some reason to come. Items “q” and “r” are 1st – 6th national placings. Item “s” would be the single best combined Novice Division horse and rider.

Costs: For “q” and “r”, 3 classes (junior, lightweight, heavyweight) per horse and rider x 6 ribbons (36 ribbons). For “s”, one award per year.

The horse and rider team shall be considered officially started when timed out on the first day of the ride.

Age of Horses

- (1) Horses competing for High Point Competitive Pleasure Team award must be at least 60 months of age.

- (a) Registered horses are considered 60 months of age as of actual foaling date on the registration papers.
- (b) Unregistered horses are considered to be of eligible age if they have a “full mouth” (all permanent incisors having erupted and in wear) as determined by the veterinary judge.

Rationale:

We already have an overall high point Open team with the Jim Menefee Memorial award. If we add a High Point Novice Team, Competitive Pleasure would be the only standard division without this award. For consistency and fairness, if the Novice passes, we should also include Competitive Pleasure. We are encouraging the team aspect and should do so across the board.

Drug Rule Appendices

At the recommendation of the Veterinary Drug Committee, the national board approved the following additions:

Thymosin Beta-4 was added to Appendix A, Prohibited Substances.


As stated in AERC's May 2018 *Endurance News*, "Thymosin Beta-4 is an amino acid chain from which Vecta

TB-1000 is derived. This amino acid chain is purported to, among other claimed benefits, increase angiogenesis (formation of new blood vessels) which in effect increases blood flow throughout the body and in turn may result in improved heart rate recovery times and overall performance. The manufacturer claims include faster

passage through endurance vet checks and attribution of multiple best condition awards to the use of their product."

CBD Oil (Cannabidiol) and other CBD products were added to Appendix A, Prohibited Substances and Appendix B, Categories of Prohibited Substances respectively.

CBD is one of many compounds known as cannabinoids that are found in the marijuana and hemp plants. Unlike other cannabinoids such as tetrahydrocannabinol (THC), CBD does not have a psychoactive effect because it works on different receptors. Due to claimed anti-inflammatory and analgesic effects, CBD oil has become popular for pain management in people and animals. Besides pain relief, CBD oil is advertised to have a calming effect in horses. Like many alternative treatments, production is not regulated, and the extraction process, which can have a significant effect on the bioavailability of CBD as well as its safety, is highly variable. Appropriate scientific studies on the safety and efficacy of CBD in equids are also lacking. CBD remains illegal in many jurisdictions and is unable to ever receive regulatory approval as a supplement since a registered human CBD-based prescription pharmaceutical (Epidiolex) already exists. Although the beneficial effects of CBD products in horses are debatable, CBD is typically applied either as a behavior modifier or as a pain reliever, either goal being contrary to NATRC rules and the spirit of fair competition.

Indian Cave Ride Drug Violation Report

As part of NATRC's drug surveillance program, horses were blood tested at the Indian Cave ride in Falls City, Nebraska on 28/29 September 2019. It was determined that horse, "Invest Ina Three Bar", belonging to and ridden by Gina Kollars, had detectable serum levels of phenylbutazone and oxyphenbutazone in its blood at the following levels:

Phenylbutazone : approximately 4.0 micrograms/ml (micrograms per milliliter)
 Oxyphenbutazone: 700 nanograms/ml(micrograms per milliliter)

Phenylbutazone and oxyphenbutazone are non-steroidal anti-inflammatory drugs listed in Appendix A, Prohibited Substances, and covered in Appendix B, Categories of Prohibited Substances.

The threshold level of phenylbutazone is 1.0 microgram/milliliter (Appendix D. Threshold Levels); thus, the level found in this horse is in direct violation of NATRC rules that do not allow horses to compete under the influence of medication. See Rule Book Section 7.

NATRC Rule Book Section 7.A.

A. General Provisions:

1. Purpose: The purpose of this rule against the use of Prohibited Substances or Prohibited Treatments in equines during NA-

TRC rides is both to protect the equines from harm and to ensure fair competition. Equines should compete under their natural abilities without the influence of any drug, medication or veterinary treatment.

2. Prohibited Substances or Prohibited Treatments as defined in this Rule shall not be administered to or used in an equine competing in a NATRC ride. No equine in which a Prohibited Substance or its metabolite is present shall compete, regardless of when the Prohibited Substance was administered to it.

Further: NATRC Rule Book: Section 5. C.6.

6. Entering the ride constitutes implied consent for drug testing.

The threshold level of oxyphenbutazone, a metabolite of phenylbutazone, is 1.0 micrograms per milliliter (Appendix D. Threshold Levels); thus the level found in this horse is not in violation of NATRC's drug rules.

A committee was formed pursuant to Section 7.E.3.c. and Section 8. E. The committee reviewed all pertinent information in determining the penalty for this protest. In communication with the committee after the positive result was detected, Gina Kollars admitted to having given her horse two grams of bute twice daily from Tuesday morning until

Thursday morning of the week of the competition. The bute was given because the horse had been inappetent after having dental work done, and she was concerned about the horse not eating. She was unsure of whether the final dose of bute had been given Thursday morning or Thursday evening; she eventually settled on morning. She admitted to knowing that her horse likely still had bute in its system at the ride but stated that she wanted to support the ride since she knew that the number of entries was small.

The committee considered 6.E.1: "A horse and rider, for the purpose of disqualification, are considered a team. Disqualification of one automatically constitutes the disqualification of the other."

Penalty determined is as follows for horse, "Invest Ina Three Bar", and Gina Kollars, riding Novice/ Heavyweight at the Indian Cave ride in Shubert, NE 28/29 September 2019:

Disqualification
 No Points; No Mileage
 Notice Printed in Hoofprint

Results of protest filed for the 2019 Pony Express Ride, Competitive Pleasure Division

A protest was filed for the Pony Express ride by Bev Roberts regarding her timing on trail concerning a downhill obstacle. Bev and her horse both lost points due to "missing the obstacle."

This protest came down to several elements of close timing, none of which could with absolute certainty be determined to the second. Several people were interviewed, including the Horseman-

ship Judge Esther Diaguila, Veterinary Judge Stephanie Ostrowski, Ride Chair Helen Smith, and Judge's Secretary Shari Parys. What on the surface appeared to be a straightforward case became more complicated with every question asked and answer received.

Ultimately it was determined that several factors contributed to the situation with no one party bearing full responsibility. Riders are responsible for maintaining reasonable adherence to their ride window timing, and judges along with management are responsible for being on location for an observation in advance of the first rider expected at that point on trail.

Due to a combination of factors, the committee **upholds Bev Roberts' protest** and finds that **the observation in question should be disallowed for the CP Division only**. Points lost to any competitor in the CP division at this obstacle should be rewarded back to the riders and horses, scores and placings recalculated, and riders notified of changes.

As Protest Chair I would like to thank everyone for their time, patience and thorough deliberation in this complicated matter.

our budget because we have underspent on marketing by approximately \$20,000, which we knew we would when we discontinued the contract with the marketing professional. Total revenue is running a little ahead. We have renewals coming in now. **Motion by DiNatale to approve the report, second by Walls. Moore opposed, Kudra abstained. Motion carried.**

BY-LAWS & RULES. Parys. The bylaws change proposals were posted on the website and sent to the membership. **Motion by Parys to approve bylaws changes, second by Dieterich. Motion carried.** Currently working on some rule clean up, condensing and clarifying for an Extreme Rule Book which takes it from 47 pages to 38 pages. Suggested we use old rule books with addendum sheets to get by until we can print a reformatted version. Some of it could be moved to the administrative section of the website rather than in the rule book. The target date for printing would be before national convention.

POLICIES & PROCEDURES. Dieterich. Editing updates, no decisions to be made.

PROTEST. Lori Allen. Three protests filed, one withdrawn. Two upheld. See separate report.

PLANNED AND CHARITABLE GIVING. Muench/Swiss. Nothing to report at this time.

NATIONAL HISTORIAN. Conner. No updates.

RIDE SANCTIONS. Conner. Report filed. List of rides provided, but not all rides are in

and it is known that the formulas are not correct on sanction report. Muench is going to help correct the formulas so it is correct in February. Dieterich said the January date for sanctioning deadline may not be appropriate anymore, and in addition the sanction chair is supposed to review the entries and ride information sheets. RMS administrators are, R1 Dieterich and Maria Pilgrim, R2 Beni DeMattei, R3 Diane Wingle, R4 Jean Green, R5 Linda Clayton and R6 Ruth Mesimer.

CLINIC SANCTIONS. Linda Clayton. Report filed.

MANAGEMENT. Swiss. Report filed. We need to provide updated information for ride management on ride flow and other things. We also need to address what is working and what is not. There is still lack of communication and training regarding LeD for ride managers. Rinne suggested use Zoom for management training sessions. Parys created a LeD quick tips document for riders and management for distribution. Meroshnekoff would like to go ahead and look to schedule two Zoom management training sessions.

RULES INTERPRETER. Wingle. Hold times are currently in the 5-10-minute range. Most rules interpreters are including maps but some are not. There was mention of the RI not being able to be physically present at LeD ride briefings while out on trail for the O/CP/N ride if all divisions are together. Wingle is currently reworking the RI Report. There is a disconnect with LeD and rules

reporting. Conner addressed situations where she questioned the ability of the RI to adequately oversee the LeD ride in conjunction with an A ride.

INSURANCE. Rinne. The premium audit was recently completed for the worker's compensation policy through Hartford. Moore reviewed our Equisure policy. We have two master policies, liability and accident.

SAFETY. Swiss. We still need to look at ensuring we have qualified people as safety personnel at rides.

MARKETING. Kris Gray. Report filed. The marketing committee wanted feedback on performance and thoughts on Facebook posts and advertising. Instagram is not very active yet. **Motion by Muench, second by Parys to continue free memberships into 2020. Motion carried.**

SOCIAL MEDIA. Jonni Jewell. Report on statistics via text were shared. Facebook page and groups for NATRC are very active and numbers are up.

BUSINESS MODEL & MEASUREMENTS. Muench. Not confident the rider numbers are completely accurate but will continue to refine. There was a slight increase in Type A competitors. The average numbers of riders has been maintaining, with eight new rides added. Muench will circulate the member numbers for our December meeting.


SPONSORSHIPS. Parys. Requested a report by region on how raffle sales are going. Bev put together an ad for the raffle that we can put on Facebook. We need to work to promote our sponsors. would be good to see how they could assist. Parys said she would help Perryman with the 4-H contacts.

FOUNDATION. Conner. We need to elect the member at large and reelect Laurie Knuutila. Rinne suggested Mary Jo Malone to replace Lory Walls for member at large. **Walls made a motion to reelect Laurie Knuutila, DiNatale seconded. Motion carried. Moore moved to appoint Malone if she accepts the appointment, Dieterich seconded. Motion carried.**

NATIONAL DRUG TESTING. Kim Murphy. Murphy is working with the Vet Drug Committee to customize a new testing panel.

VETERINARY DRUG COMMITTEE. Dr. Tamara Gull. Report filed. The committee has recommended the addition of three prohibited substances. Thymosin Beta-4, CBD Oil and medicated hoof packing products. Parys talked about the disconnect between listing a brand name, without listing the ingredients. The anti-inflammatory properties within Magic Hoof, for example, are not listed individually as prohibited. Meroshnekoff stated it might make the most sense to add iodine and turpentine individually to the list as opposed to saying medicated hoof packing products. **Motion by Walls to add thymosin beta-4, seconded by Muench. Motion carried. Motion by Muench to add CBD oil products, second by Walls. Motion carried.** It was suggested that printing of the drug appendices/prohibited substance list be added to the Management checklist.

TRAIL ADVOCACY AND GRANTS. DiNatale. Grant submitted for consideration from Region 2 at Los Penasquitos Canyon Preserve. Meroshnekoff stated the bridge is greatly needed, and there are two NATRC rides a year held there. **Motion made by Moore to approve the \$500 grant, seconded by Dieterich. Motion carried.**

EDUCATION. Dieterich. Most of the education this season has been focused on LeD Judge training. Cowart and Dieterich have been working in groups and individually with prospective judges. There is a great need for better dissemination of information. Rinne suggested the development of the online library when time permits.

ride chairs, judge applicants, provisional judges and official judges. We continue to work to recruit more judges. Parys said we need to increase visibility of the process and what it takes to apply, especially for the LeD. **Motion by Muench, second by Walls to approve Lori Allen as horsemanship judge. Discussion. Kudra and Moore opposed. Motion carried. Motion by Muench, second by Walls to approve Keri Riddick, DVM, as veterinary judge. Motion carried.** It is suggested to revive the Judges Forum.

HALL OF FAME. Rinne. No applicants.

STUDENT LOAN/SCHOLARSHIPS. Kay Gunckel. No applications.

BREED & ORGANIZATION LIASONS. Stucky. Will be working with Amy Martin to learn the ropes for the role.

AHA. Insko. Talked about the AHA national ride and wondered if we could somehow join organizations for this ride. The ride moves around to different locations. If a local ride sanctions with AHA, as the co-sanctioning organization our rules apply. AHA members with competition cards can qualify for AHA performance points as competitive trail is an approved event.

HONORARY & APPRECIATION. Mesimer. Report filed. National honorary and appreciation award nominations were made, voted on and approved. **Motion by Moore, second by Perryman to approve regional appreciation nominees by acclamation. Motion carried.**

ANNUAL POINTS. (Change to TECHNOLOGY) Andrea Rogers. The Coreware team is currently working on the phase to get ride results directly into the system, and that is close to completion. We would like to have someone in each region to be the data entry admin. Linda Clayton R5, Ruth Mesimer R6, Jamie Dieterich for R1 and R1A, Lory Walls for R2. Regions 3 and 4 need admins. Rogers is working on a duties sheet for the admins. Muench recommended we add these admins to the Technology committee.

ELECTRONIC MEETING COORDINATOR. Remove from agenda.

CONVENTION. Muench. San Antonio. There is a window for the hotel for reservations, and R4 needs to know if the room block needs to be reduced. More expensive venue, but it is a destination location and very nice. Wednesday evening meet and greet for the board, with the formal meeting

on Thursday. 2021 national convention will be in Omaha, NE and is in the planning stages.

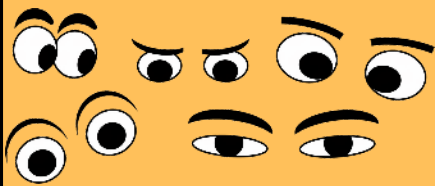

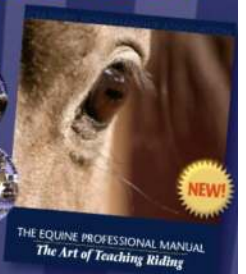
