

## FOUNDATION DIRECTORS AND OFFICERS

**A. Foundation Board of Directors.** The Foundation is a separate corporation from NATRC and has its own Board of Directors. *The number of initial directors shall be nine (9), consisting of six (6) members elected by and from the NBOD, with one (1) from each region, (“NATRC Directors”). In addition, there shall be three (3) members elected by, but not from, the NBOD.* The election of the Foundation Board of Directors will take place during the annual meeting of the NATRC NBOD meeting. Traditionally, the Foundation directors are the senior National directors from each region.
